We are honoured to invite you to participate at international scientific conference:

"THE CONTEMPORARY INTERNATIONAL LEGAL ORDER AND EUROPEAN INTEGRATION OF SERBIA"

which will be held on <u>December 10, 2014</u> in Belgrade, at the Institute for International Politics, Makedonska 25 Street.

The focus of the conference, which will be held in Serbian and English, will be the question of Serbia in the contemporary international legal order, with special emphasis on its position in the European integration process. Thematically, the conference will cover several international legal fields, from the systematic monitoring of the development and codification of international law to the problems relating to the position of the states and other subjects of international law in contemporary international relations. The conference will also consider issues of international human rights law, international humanitarian law, diplomatic and consular law, international law of treaties, environmental law and law of international organizations. In the last mentioned case, the emphasis will be given to the theoretical debates that deal with the relationship of international law, European Union law and national law, as well as the interpretations drawn from contemporary international jurisprudence. Particularly will be discussed and opened questions concerning the harmonization of national legislation with the European Union law, as well as the institutional aspects of the accession of Serbia to the European Union.

We would kindly ask you to submit the title and abstract (100-200 words) with keywords (5-10), in Serbian and English, by e-mail to: d.todic@diplomacy.bg.ac.rs, or dtodic@ymail.com, no later than 5
November 2014. Bearing the mind that it is planned that the proceedings in the CD version are to be published by the beginning of the conference, please provide your papers no later than 20 November 2014. Authors will be notified on the acceptance of papers by 25 November 2014.

The conference program will be subsequently submitted.
